The Preble County Retired Teachers Association met for lunch Nov. 10, 2015 at St. John's Lutheran Church in Ingomar. Pat Deeter and Nancy Wright greeted members as they entered. Betty Brenner gave a short Veterans Day program followed by a prayer and the Pledge of Allegiance. President Crelin thanked the church ladies for the meals all year and she passed around a volunteer sign-up sheet for the 2016. A drawing was held for the 4 door prizes and the basket was passed to donations to Tools for Schools.

Following the meal, the members assembled in the sanctuary of the church for the music program given by: Sheryl Mabry, Pat Brooks, Mary Holman and Matt Shoemaker. They played a variety of instruments and Sheryl sang patriotic and Thanksgiving songs.

Because Mary Holman had to get back to school, the meeting followed the program. Board members gave the following reports: The Recording Secretary's report was approved as written in the last newsletter with a motion by Phyllis White and second by Jo Ann Hoffman. The treasurer's report was also in the Newsletter. The executive board had approved of up to \$200 to be spent on books from the PCRTA for the Christmas for Kids project.
